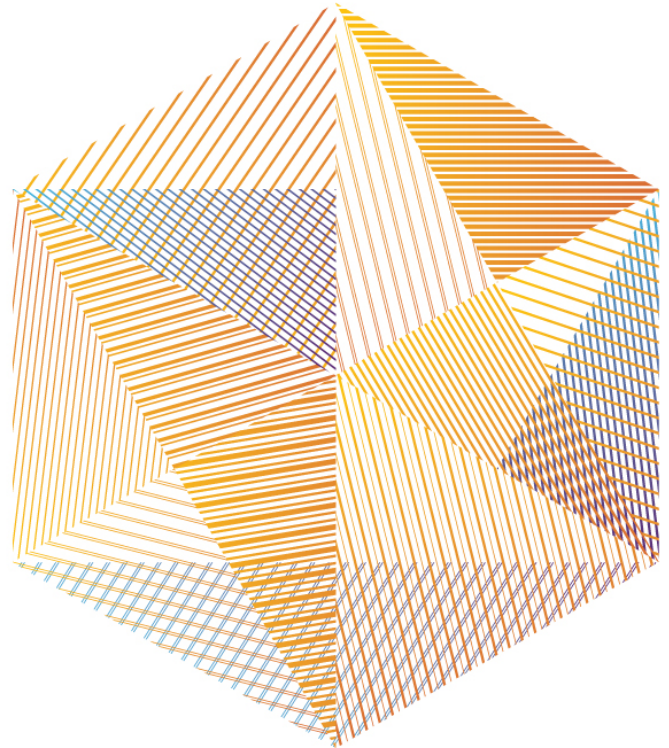

Brokerage costs
